LWCA Hires Pool Management Company for 2023 Season



The New Jersey Pool Management & Staffing Co. will operate the Lakeridge West pools for the 2023 season. This contract is the largest single expense the Association faces and one that requires much in-season attention. NJPM will hire, train, and supervise three certified lifeguards daily, and handle routine operational and maintenance issues connected to the pools.

With LWCA's financial constraints, the Association entered into a contract that is considerably less than the 2022 contract but also curtails our hours of operation. The pool complex remains open daily but with shortened hours during the month of June, longer hours in July and August, a few late night Friday swims, and extended weekend hours.
