## LWCA Hiring Lifeguards Now for Our 2024 Self-Managed Season



Some of our experienced and familiar lifeguards will be returning this summer, but we still have a few openings for this season. Applicants must be at least 15 years old, hold lifeguard certification, and be conscientious. LWCA welcomes local resident applications, and provides flexible scheduling and incentives for experienced guards. All lifeguards earn at least minimum wage.

LWCA lifeguards will be under the supervision of our own pool manager and head lifeguard. For the first time in many years, we are returning to a self-management model, rather than hiring an outside pool management company.



It is anticipated that the switch to self-management will provide a better experience for residents, onsite daily supervision, faster resolution of issues, and some financial savings. During this transition, the Board is being assisted by a local resident with long-time experience in managing swim operations at private clubs and pools.

## Annual Assessment due on April 1



The 2024 Annual Assessment in the amount of \$650 is due on April 1. Those who pay in full by that date will receive 20 free guest passes for use throughout the summer.

In accordance with our governing document known as the Declaration, the Assessment is actually due on March 1, but the Board has extended the deadline to April 1. In accordance with our bylaws, failure to pay the annual Assessment by the due date will result in late charges and other penalties.

The Annual Assessment supports the maintenance and operation of our collectively-owned pool and other facilities.
