A Little History as LWCA Addresses Bylaw Revisions



The Lakeridge West Community Association was the vision of our developer, Levitt and Sons, in 1966 who planned a residential community with commonly-owned lands and amenities for recreational purposes. The Association was then incorporated as a not-for-profit in the State of New Jersey later that same year. LWCA is a 501c 7 corporation that includes certain requirements for exemption from federal income tax.

Two over-arching documents—known as “The Declaration...” and the Certificate of Incorporation—govern LWCA memberships, voting rights, fundraising, and many other provisions. Both are available on our website, www.lakeridgewest.org.



Around the same time, a series of Bylaws were written that address the establishment of the Board of Trustees, election procedures, meetings, collection of assessments, etc. The Bylaws cover many of our day-to-day operations and are also available on our website.

The Board will begin a review of our Bylaws to assure that they are current and relevant.
