Lockport Main Street Inc, in partnership with the NYS Canal Corporation is pleased to present the 6th annual Locktoberfest, a community celebration of the fall harvest season on the Erie Canal. This celebration is scheduled for Saturday, September 28, 2019 from 9:00 am to 5:00 pm on Canal Street in downtown Lockport.

The Community Market will run from 9:00 am to 5:00 pm. With all day music and food vendors on site.

Lockport Main Street Inc will work with the City of Lockport, the NYS Canal Corporation, the Locks Heritage District Corporation, and Niagara Falls USA to promote the event, as well as build a safe and engaging festival. The event will be heavily promoted throughout the region, and we expect over 5,500 attendees, based on last year's attendance. Highlights of the event include the following:

- An expanded Lockport Community Market on Canal Street.
- Designated beer garden with local, craft beer sold by the glass.
- Crafters, artisans, wineries, distilleries farmers and food producers.
- Flight of Five Locks Tours, ribbon cutting ceremonies of the first Locks Tenders Monument pieces, canal craftsmen demonstrations and partnering activities with Lockport tourism leaders.
- Musical Entertainment and Live Performers.
- Children's Games and Family Activities.

MARKETSPACE VENDOR, LOCKTOBERFEST APPLICATION

- **Spaces are located on Canal Street and are \$35 for farmers/food producers and artisans/crafters.** All spaces are 10' x 10' and will be available on a first signed-up basis. Current Lockport Community Farmers Market Vendors will have priority to the application, all current market vendors will pay their current weekly fee for the event. Vendors will be given a space number, instructions on unloading and loading, and parking, prior to the event.
- There will be no vehicle parking (other than food trucks) in any of the Canal Street parking lots, as the area will be closed off after 8:30 am for safety reasons. Vendors will be asked to unload and then move their vehicles to a designated adjacent lot.
- **Please mail your application with payment no later than Saturday, August 31, 2019 if you wish to participate. The committee reserves the right to reject any application based on the appropriateness of products as they fit into the intended image and goals of the event.**
- If you are signed up and cannot attend, please contact Jessica Dittly at 716-434-0212, or email at LockportMarket@gmail.com no later than September 21, 2019. Any cancelations after September 21 will forfeit their vendor fee.
- If any persons will be vending on behalf of your business other than those listed on this application, please provide the names to Jessica Dittly prior to the event.
- Vendors should be prepared to get themselves set up, torn down and bring everything with them needed to conduct business for the day including: 10 x10 tent, tent weights (mandatory), chairs, tables, products, change/money, etc.
- Set-up will begin at 7:00 am and all vendors should be completely set-up and ready to greet customers by 9:00 am sharp. Items for sale at the event must correspond to what is listed below. Be prepared to be scheduled to arrive as early as 7:00am, due to the event space vendors will be scheduled in half hour intervals to arrive and you must be prompt, or you will loose your assigned vendor location.
- Your booth must always be manned, breakdown may not take place prior to 5:00pm.
- The event will take place rain or shine. No rain dates will be offered. The event will only be cancelled in the event of severe or dangerous conditions. The organizers of the event will contact vendors that morning if there is a need to cancel.
- Participation is limited to legitimate farms and businesses as defined by New York State and Federal regulation. Farmers and Food Vendors must have proper permits as defined by the Niagara County Health Department.
- Vendors participate in the event at their own risk. Individual insurance for all vendors is strongly recommended. By signing this application, vendors release the City of Lockport, the Lockport Community Market, Lockport Main Street, Inc., the NYS Canal Corporation, the LHDC, and the GLDC from any or all liability or responsibility for bodily harm or injury.
