Special contracted rates will be applied on the following month. New contracted rates will then change to \$75.00 plus taxes per service requested. Fleet member will be notified of such change, should account be eligible.

By signing this agreement, you acknowledge that you have carefully read, understand, and fully agree to the terms. Any details not included in writing in this agreement are not binding by either party. Should the details of this agreement be contested and result in arbitration or litigation, the prevailing party is entitled to recovery of all reasonable legal expense. The person signing as Companies Authorized Person below will be fully responsible for ensuring that full payment is made pursuant to the terms of this agreement. The Laws of the State of Hawaii will govern this agreement and the Courts of the First Circuit Court, City and County of Honolulu will have jurisdiction.
