## COURT OF HEAVEN PRAYER FOR INHERITANCE



Based on Joshua 14:6-14

[Begin in Worship and Surrender]

Heavenly Father, I come before You in worship. You are the Righteous Judge, the Ancient of Days, the God of justice and truth. I acknowledge Jesus Christ as my Savior, my Advocate, and my Intercessor, seated at Your right hand. Holy Spirit, be my Counselor, my Witness, and my Guide in this court session.

[Step into the Courtroom by the Blood]

By the authority of the blood of Jesus, I now step into the Court of Heaven. I enter not by my own righteousness, but by the finished work of the cross. I silence every voice of the accuser by the blood of the Lamb (Revelation 12:10–11). I renounce all agreement with lies, fear, unworthiness, and limitation.

Father, I ask that the books of destiny concerning my life be opened (Psalm 139:16; Daniel 7:10). Let the scrolls be brought forth that contain Your plans, Your promises, and Your inheritance for me. I ask for angelic witnesses to stand in agreement with what is written.

[Present Your Petition]

Righteous Judge, according to Joshua 14, You honored Caleb's faith and gave him his inheritance at the set time. I now come into agreement with that same prophetic pattern. I declare: It is my time!

You have seen my journey. You have seen my battles. You have seen my obedience in the wilderness seasons. And now, like Caleb, I petition this Court: "Give me my mountain!" Give me what You have promised—my spiritual inheritance, my family restoration, my financial breakthrough, my calling and destiny.

[Request Legal Action]

I ask now that every demonic resistance, legal case, or counterfeit claim standing against my inheritance be overruled in this court. Let every word curse, generational bondage, or soul tie that would disqualify or delay me be rendered null and void by the power of Jesus' blood.

I ask for a divine verdict of release to be issued in my favor.

I ask for divine restraining orders against every spirit of delay, sabotage, slander, and injustice.

I ask for the record of the accuser to be sealed and erased by the mercy of God.

## [Declare Alignment and Readiness]

I align myself now with Heaven's agenda. I surrender every place of doubt, rebellion, or weariness. I declare I am ready to occupy the land. I am equipped, anointed, and appointed for such a time as this. I carry another spirit—the spirit of faith!

I receive strength, boldness, clarity, and courage like Caleb. I declare I am not disqualified—I am chosen, preserved, and positioned. I will not die in the wilderness—I will possess my promise!

## [Receive the Verdict and Blessing]

Father, I thank You for the gavel of justice falling in my favor. I receive the heavenly verdict:

- The mountain is mine.
- The timing is now.
- The enemy has no more access.
- The doors are open.
- The promise is activated.

Let there be no more delay! I declare full manifestation in the natural realm.

In Jesus' mighty name, sealed by the blood, by the Spirit, and by the Word—

So let it be written. So let it be done. Amen and amen!
