Parade Rules and Regulations

Saturday October 4, 2025, 2:00pm



- *Parade Meeting – Wednesday October 1, 2025 @6pm - Farm Bureau Office 3139 Veterans Memorial Dr (A representative from each Float and Marching/Dance must be present.) We will cover all rules and regulations.
- * All entry fees must be paid in full prior to the parade. No unit will be allowed to participate without a completed entry form, release, along with fees. There will be no refunds.
- *Floats are to be rented directly through the float rental company – If a truck is needed from us to pull the float you will need to let us know once you rent the float.
- *For float rental needs you can contact All Season Float Rental – Layla @337-522-3734/Buford@337-522-0122
- *The La Cattle Festival Parade begins at the Railroad tracks on South State St. and will turn right on W. Lafayette St., left on St. Charles, left on E. Vermilion St. left on North Washington and ends at Magdalen Square. (See attached map)
- *Floats and float vehicles will meet to line up at AA Comeaux Park beginning @ 12:30pm. Police escort will leave no later than 1pm to proceed to parade lineup.
- *Individual Vehicles & Marching groups will line up on Avenue Railroad beginning no earlier than 1pm.
- *You must be lined up by 1:30pm and will NOT be allowed to enter lineup after.
- *There is no official order for lineup. The lineup will be determined by whoever arrives first.
- *No trailers over 30' (thirty feet) in length allowed. (Due to turns)
- *All floats or vehicles must have a sign identifying organization, person, etc. All signs must be readable from a distance. BIG BOLD LETTERS are to be used.
- *All throws must be limited to beads, plastic cups, toys, candy, etc. (please refrain from throwing soft candy as it melts fast on the road and it is harder to clean after parade ex. Tootsie rolls). No sharp or sexually explicit throws will be permitted. All throws must be thrown as far away from the float or vehicle as possible. No throws can be thrown unless the parade is in motion, nor can they be handed to anyone approaching the float or vehicle. DO NOT THROW UNTIL YOUR FLOAT OR VEHICLE REACHES THE CROWD AT THE START OF THE PARADE! NO CONFETTI ALLOWED TO BE THROWN!
- *NO person will be allowed to ride or stand on vehicle roofs or hang off floats. Any violation of this rule will result in immediate removal from the parade. This will also result in forfeiture of parade fees paid.
- *Drivers must proceed with caution keeping one car length behind the entry ahead of them and follow all state and local laws concerning traffic and alcoholic beverages for the safety of all. POSITIVELY NO DRINKING BY THE DRIVER!
- *Any operator of any float or vehicle that is suspected to be under the influence of alcohol will not be allowed to participate. Groups may also be disqualified. Any operator caught consuming alcohol while operating the float will be pulled from the parade.
- *No vulgar music or behavior allowed. All costumes/clothing must be appropriate and suitable for family viewing and in good taste. Remember this is a Family-Kid Friendly Parade!
- *The designated stops noted on the map are the only times any group is allowed to do performance. Any other stops made due to parade you must proceed when the parade resumes. **Max time allowed is 2 minutes at designated stops.**
- *Anyone not in compliance with these rules is subject to removal from the parade and may be prohibited from future participation. Parade fees will not be returned.
