Season Contract Agreement

I/we, _____, understand that, in accepting a place on the GALAXY GYMNASTICS JUNIOR OLYMPIC TEAM, I/we, the parent(s) are committed to meet the obligations of the Booster Club (GGBC) for the 2021-2022 season. This obligation is imposed in your contract with Galaxy Gymnastics. Galaxy Gymnastics Booster Club is a non-for-profit organization run by parents. This organization was founded to support the gymnasts and fundraise to help offset costs that accrue in this expensive sport. As a member of the team, you are expected by Galaxy Gymnastics to attend all meets required asset on the schedule provided by Galaxy Gymnastics. The Booster Club Treasurer will create a budget for the season that includes membership dues, meet fees, expenses (including travel costs for coaches) and results of fundraising efforts. I/we understand that this budget is approved by the Board and that I/we are required to pay all fees assigned for your designated level. Membership dues and meet fees vary by level and can range from \$500 - \$1,500 for the season. I understand that I am financially responsible for the dues and meet fees required for my level. If your level changes mid-season, you are responsible to pay the difference in membership dues. All level changes are made by Galaxy Gymnastics. The budget will be prepared after the meet schedule is released and presented to the team in September. The dues and meet fees owed will be required to be paid between September and December based on the schedule decided by the treasurer. The host clubs of the meets we go to require us to register and pay as early as July. We pay early to avoid the meet being closed out before we register. The majority of our meet fees are paid by November 15 each year. If your account is not paid in full by December 31, your child will be scratched from all meets and ineligible to compete until the balance is settled. As a team, you are expected to attend all meets required for your level. The team is relying on all gymnasts participating to contribute our team score at meets. If you need to scratch your daughter from a meet, you must get approval from Jamie Winkler, head coach/owner of Galaxy Gymnastics, and then inform the Booster Club Treasurer and President via email at least 24 hours prior to the scratch date. If the scratch is approved by Jamie Winkler and the booster club is properly notified before the meet scratch date, the treasurer will refund your meet fee. We cannot refund meet fees that are not properly scratched. I understand that if I/we join the Galaxy Gymnastics team and the Galaxy Gymnastics Booster Club during the competitive season, I/we understand that membership dues are NOT pro-rated unless you join the team after your final competition of the year. If your daughter decides to leave the team prior to September 15, any payments you made towards the current season will be refunded. If your child leaves the team during the meet season, after September 15, you will be refunded for all meet fees that are prior to the scratch.

Galaxy Gymnastics Booster Club 2021- 2022 Season Contract Agreement date. There is no refund for membership dues after September 15. I understand that any unpaid balance upon leaving the team will be charged to my bank account or credit card below. If your daughter is injured for the season and does not compete at any meets, dues will be reduced. A gymnast that competes at least 1 meet (4 events) is not considered injured for the season and is required to pay full membership dues for their level. The budget is determined based on participation of all gymnasts so we cannot make any exceptions to this rule. Galaxy Gymnastics hosts up to three home meets each year. As a member of the Booster Club and Galaxy Gymnastics, each family is responsible for working all home meets, regardless of whether your

child is competing in the meet. You must work all sessions that you are assigned to. The number of sessions each family is responsible for is equal to the number of jobs required to run the meet divided by the number of families working. If you are unable to work your assigned sessions you must provide coverage for the time you are scheduled to work. I understand that if I do not provide somebody to cover my required working sessions, I will be charged \$250 for each session missed. Please ensure you find coverage for your sessions to avoid being charged this fee. The Booster Club is not responsible to find coverage for you. Payment Information A valid bank account or credit card number is required to be on file with GGBC for membership dues, meet fees, and missed session fees. Invoices will be sent to your email address on file in advance of the payment due dates. We will not automatically charge your account, so please make sure you pay when you receive your invoice. We only automatically charge your payment method below when you are more than 10 days late on making payments. A late fee of \$10 will be added to your payment if we need to process payment on your behalf.
