# Suggestion: Advance Global Policing via Robust Collaboration between Local Law Enforcement, Contract Security, Cybersecurity & Others

- Collaboration between Law Enforcement & Corporate/Contract Security a Major Federal Priority & Federal Practice for Decades
  - Numerous Federal & Security Industry Initiatives Have Never Taken Off
  - But Major Law Enforcement/Corporate Security/Contract Security is Now A Reality
    - See, e.g., NYPD Global Shield Network
- Collaboration between Law Enforcement & Cybersecurity Firms Has Been a Reality in investigating Cybercrimes for A Decade or More
- Why? Very Large & Highly-Specialized Corporate/Contract Security Firms have access to large untapped info sources highly relevant to public safety; and Many Firms are interested in Info Sharing with Law Enforcement

## Suggestion: Advance Global Policing by Similar Global Collaboration

- The World has Shrunk Over the Last Two Decades
  - Expansion of Global Trade and Global Supply Chains
  - Increased global travel for business, education and tourism
  - Increased International Flight Risk, Human Trafficking, Cybercrime and Terrorism
  - "Open Borders" Issues suggest increased domestic presence of global threat actors
- Sheriffs & Municipal PDs Engaged in Global Policing for the Last Decade or More:
  - <u>Driven by Practical Operational Needs</u> in investigations, victim response and fugitive returns, for quicker and easier global collaborative relations
- Vetted and Trusted Contract Security & Cybersecurity Firms Have Access to Vast Pools of Global Security information valuable to Law Enforcement
- Cybercrime & Terrorism response heavily dependent on global relationships
- Interpol Exec: "multibillion-pound syndicates are destabilising countries, driving migration and destroying ecosystems", May 2024

## NYPD Global Shield: Powerful Global Policing Model for US Local Law Enforcement

NYPD has Blazed the Path Forward on Global Policing for US Local Law Enforcement

- "Global Shield Network (GSN) consists of Law Enforcement/Intelligence Agencies from around the world that share information and intelligence and encourage collaboration with private sector partners."
- "Global Shield ... partners [NYPD] Counterterrorism Bureau with private security managers across the region."
- NYPD Global Shield Members (Dated Published Info)
  - US Law Enforcement & Local Shield Programs in US
  - European Police: e.g., Antwerp PD, Belgium National Police
  - Leading Corporate Security Departments & Firms
- Global Shield Participants: "The NYPD Shield program is designed for <u>Security Directors</u> (or their equivalent), <u>Assistant Security Directors</u>, <u>Security Managers</u>, <u>Law Enforcement</u>, and <u>Government Agency Personnel</u>."

# Law Enforcement/Non-Law Enforcement Collaboration Happening at Federal Level & Globally

- Federal Cybersecurity Information Sharing Act of 2015
  - "improve cybersecurity in the United States through enhanced sharing of information about cybersecurity threats"
  - authorizes sharing of Internet traffic information between the U.S. government and technology and manufacturing companies
  - make it easier for companies to share information with the government, especially in cases of cyber security threats
  - creates a system for federal agencies to receive threat information from private companies
- CISA Modernizing Automated Indicator Sharing Program
  - <u>simplify info sharing processes across USG & Public and Private Stakeholders</u>

# INTERPOL—Promoting Benefits of Global Policing & Law Enforcement-Non-Law Enforcement Collaboration

"Information exchange between police and private industry is key to developing a comprehensive global response in particular in the aftermath of an attack"

- The private sector typically holds more detailed data on cyber threats, attacks and victims than traditional law enforcement agencies
- Private entities offer a dynamic insight into new technologies and solutions
- Provides Business Community access to a global network of key stakeholders in law enforcement

## "Public Security" & "Global Public Security" Defined
