**New Business:** Supervisor Horacek stated that he had received a call from the highway supervisor for the Town of Big Flats. He told him he is looking to see about getting funding for 7th Ave. Since this is a shared road with Colburn, he wanted to make sure the town would be okay with it. Supervisor Horacek told him if Colburn doesn't have any cost in it, that would be fine.

**Assessor Contract:** A motion was made by Supervisor Horacek; 2<sup>nd</sup> by Supervisor Guajardo to accept 2025 assessors' contract in the amount of \$6,800.00     **Motion Carried**

Treasurer Holmes ask if the town was going to be reassessed in 2025. Chairman Gold stated that we have to wait because the cost of having that done is between \$25,000 and \$30,000. Treasurer Holmes then asked if we would be able to use the shared revenue because the amount, we are receiving should be about \$39,000. It was decided that the town would wait to see if that shared revenue of \$39,000 is received next year.
