Mike: Trimmed trees, took truck to Mid-State Trucking

**Wayne:** Took down snow fence, helped take wing & plow off plow truck & grader. Put up fire signs & called Diggers Hot Line. Graded a few roads. Trimmed trees. Went to the dump.

**Fire District:** The chief wasn't there to give a report. They made a motion to put in a back up generator. Also to upgrade the electrical box. In the amount of \$36, 645.00. The cost to the Town of Colburn will be \$3,375.00.

**Old Business:** Clerk Horacek present Resolution 2023-02 for the Rustic Road approval for Bighorn Ave. from 7<sup>th</sup> Ave. to 5<sup>th</sup> Ave.

**New Business:** 2023 Road project, Badger Dr. from County G to 4<sup>th</sup> Ave. in the amount of \$70,127.00. Motion by Supervisor Horacek, 2<sup>nd</sup> by Supervisor Guajardo to approve the amount. **Motion Carried** 

**Public Comments:** It was asked if the money that was being used for the fire department upgrades was coming from the town's Lee Holmes account. It was stated the Lee Holmes had also donated money to the fire department. None of the town's donation would be used for that.

Dave Breitkreutz then asked when the town was going to finish the ditch work along 6<sup>th</sup> Ave. He stated that he had put his own money into cleaning out the ditch. Now the town needs to clean it up a bit more. The board stated they would look at it.

It was asked what the town came up with on Badger Lane Private. Chairman Gold stated that he did take a look at the road, He gave their representative papers on what would need to be done before the town would even consider taking the road over. He also stated the cost to seal coat a 1 mile section of road cost \$80,000.00 without gravel that would be needed on that road. It was then asked if the town would plow and sand the road. It was stated that the insurance company would not cover it.
