Highway:

Terry: Took plow and sander off the truck, had to put the plow and sander back on the truck. Went to get sand. Helped clean up after the first fire. Took stuff out of the town shop and put in the town hall. Took stuff out of the town hall and moved it to the shed. Clean the plow truck after the fire. Took plow off the truck. Hauled gravel. Put mower on the tractor. Checked roads for potholes. Repaired stop signs and ditch markers.

Wayne: Helped clean up after fire. Cleaned the grader after the fire. Graded roads checked roads for potholes. Moved stuff out of town hall, put in shed. Repaired stop signs and ditch markers.

Chairman: Asked Supervisor Horacek to flag the culvers on 6th Ave that will need to be replaced for the road to be repaired.

Supervisor Horacek: Suggested taking down all the ATV/UTV Signs. They would be replaced with signs that say all town roads are opened unless posted. It was agreed to replace the signs now that the state changed the laws that a sign is not needed at every crossroads.

Fire District: The update at the last meeting was that things are going much better at the fire department. The morale is much better with all the firefighters. They approved to lease the building to the Coloma Fire Department for \$1 a year. The new rescue truck has the decals on it and is getting the lights put on it now. The board informed them they needed to sell the equipment that is not being used anymore.

Old Business: Supervisor Gold an estimate form True North Steel to replace the bridge on 5th Ave. With everything needed the board figures the cost would be about \$60,000. Supervisor Gold will ask the company to come back and get detailed measurements for the repair.

New Business: Clerk Horacek read the Resolution 2020-01 to declare an emergency in the Town of Colburn due to the April 18th fire at the town shop. The shop was a total loss. A motion was made by Supervisor Gold; 2nd by Supervisor Horacek.
