The regular monthly meeting of the Greenfield Township Supervisors was called to order at 8:08 pm with the pledge of Allegiance.

The roll call was Supervisor Totsky present, Supervisor Mancuso present, Supervisor Bonczkiewicz present, Attorney Casper present, Secretary Brewer present. A Supervisor's quorum was present, so the meeting was able to proceed.

There were no corrections to the minutes of the December 5th meeting and the December 27th 2024 budget meeting by the Supervisors, so the minutes stood approved as distributed.

Supervisor Totsky moved to close the regular meeting and open the 2024 reorganization meeting. Supervisor Bonczkiewicz seconded that motion. The motion passed with a voice vote with all Supervisors present voting yes.

Howard Evans noted that there should be training for the new Zoning Board members. There were no other public comments regarding the reorganizational appointments.

Joe Hunt Associates (JHA) as alternate Sewer Enforcement Officer. Reappoint Kim Fortuner as chair, Joseph Graziano, Tammy Kelly, Karen Armfield, and Michael Wagner to the Zoning Hearing Board. Reappoint Attorney Frank Bolock as Solicitor for the Zoning Hearing Board. For Northeast Inspection Consultants to handle zoning and permits. First National Bank as the Township Depository. To set the Treasurer's Bond at \$250,000. Berkhiemer as the earned income collector. That the 2024 millage rate remain at 19 mills. Retain the firm of Donald G. Karpowich, Attorney-at-Law, P.C. as conflict counsel

for the Township, and as hearing officer for special conditional use applications. To make the first Tuesday of each month at 8pm as meeting night for 2024 and if it falls on a holiday or on election day, then it will be the next Tuesday. That the Township Holidays be New Year's Day, Good Friday, Memorial Day, July 4th, Labor Day, Thanksgiving Day, Veteran's Day, and Christmas Day.

Supervisor Totsky seconded that motion. The motion passed with a voice vote with all Supervisors present voting yes.

Supervisor Totsky moved to adjourn the meeting. Supervisor Mancuso seconded that motion. The motion passed with a voice vote with all Supervisors present voting yes. The meeting was adjourned at 7:02pm.
