

Greenfield Township Supervisors' Meeting – March 3rd, 2026 Meeting Minutes.

The regular monthly meeting of the Greenfield Township Supervisors was called to order at 7:00 pm with the pledge of Allegiance.

The roll call was Supervisor Mancuso present, Supervisor Bonczkiewicz present, Supervisor Jenkins present, Attorney Favreau present, Secretary Brewer present, Treasurer Rudalavage present. A Supervisor's quorum was present, so the meeting was able to proceed. There were no corrections to the minutes of the February 3rd meeting, so the minutes stood approved as distributed.

The Township departments read or stated verbally their reports as available.

There were no public comments on agenda items.

Supervisor Mancuso opened the hearing regarding the consideration of the Norlack comprehensive plan. Supervisor Jenkins stated a review of the contents in the plan regarding how it affects Greenfield Township and recommended the supervisors adopt the plan. Supervisor Bonczkiewicz moved to adopt the plan. Supervisor Jenkins seconded the motion. The motion passed with a voice vote with all Supervisors present voting yes.

After an explanation by Solicitor Favreau on the Comcast Cable Franchise Agreement changes, Supervisor Jenkins moved to approve sending the changes to Comcast. Supervisor Mancuso seconded that motion. The motion passed with a voice vote with all Supervisors present voting yes.

Supervisor Bonczkiewicz moved to authorize Solicitor Favreau to advertise notice of soliciting offers to purchase a Vibratory Roller. Supervisor Mancuso seconded that motion. The motion passed with a voice vote with all Supervisors present voting yes.

Supervisor Mancuso moved to Authorize Solicitor Favreau to advertise notice of soliciting bids for the sale of certain used equipment currently owned by the Township. Supervisor Jenkins seconded that motion. The motion passed with a voice vote with all Supervisors present voting yes.

Supervisor Jenkins moved to Update millage rate from .12 to 1.2 mills. Supervisor Bonczkiewicz seconded that motion. The motion passed with a voice vote with all Supervisors present voting yes. Supervisor Mancuso stated the reason for the change was a scrivener's error.
