Mayor DeRossett called the meeting to order at 7:00 pm, followed by the Pledge of Allegiance.

Minutes:

The minutes from the September 20, 2023 meeting were read individually. Mayor DeRossett mentioned that under Greg's report it stated Spencer Feed and it should say Spencer Forge regarding the old school building. A motion to approve the minutes as amended from the September 20, 2023meeting made by Gehring, seconded by Gauchat, with all present council members voting "aye". Motion carried 5-0.

Treasurer's Report:

The treasurer's report was reviewed. A motion to approve the treasurer's report made by Gehring seconded by Walter, with all present council members voting "aye". Motion carried 5-0.

List of Bills:

The list of bills was reviewed. A motion to approve the list of bills made by Walter seconded by Gauchat, with all present council members voting "aye". Motion carried 5-0.

Gov't agencies etc:

• Debbie Kiley from the Medina County Office of Older Adults was present and discussed the upcoming levy on the ballot for the county services provided by them, ADAM, and Job and Family Services

Mayor's report: Dan DeRossett:

- Mayor reported that the snow plow had been installed, the plow truck is being repaired, and the road salt ordered
- Mayor asked council for some help in getting newer estimates for the roof and the electrical work at the legion. He discussed earlier estimates, but they are pretty old and he wanted to get three each to compare.
- Mayor discussed the estimate for timbering Firestone Park. It came in over \$50,000, so Huber explained that it had to be bid out. He will draw up the language for the advertisement in the paper.
- Mayor had a bill from Susan Hirsch for help with the LMRE electric substation. Her bill was not part of the original contract for the zoning updates, but since there was nothing in our zoning for substations, they needed her input for the LMRE project and future development.
 - o A motion to approve the \$250.00 bill from Hirsch made by Kiousis, seconded by Krystofek, with all present council members voting "aye". Motion carried 5-0.

Solicitor's report: Greg Huber:

- Huber had many questions about the campers on North Main. He stated that he needed more information and an investigation on it, not just pictures, if he was going to file a suit against them.
 - Mike Wright said he had been watching the property for 23 days to establish a pattern, while gathering video and OLEG information on license plates.
 - Huber said he needs names as well, and that the zoning inspector can cite them under our zoning laws.
 - Herrick said it was the first time he had heard that anyone had been living in them, and was willing
 to help out, but also stated that he needs to be made aware of issues before he can rectify them as
 well. He will cite them immediately and work with Wright moving forward.

- Kiousis said the committee discussed getting the cruisers undercoated. Council discussed getting the other vehicles done as well. The company is Goods in Marshallville and the cost is only around \$50.00 per vehicle.
 - A motion to approve up to \$500.00 to have all the vehicles fluid filmed, made by Kiousis, seconded by Krystofek with all present council members voting "aye". Motion carried 5-0.
