

ORDINANCE NO. 1-78

AN ORDINANCE FIXING THE MAXIMUM SALARYS AND/OR WAGES OF THE OFFICIALS AND EMPLOYEES OF THE VILLAGE OF SPENCER, MEDINA COUNTY, OHIO EFFECTIVE JANUARY 1, 1978 AND DECLARING AN EMERGENCY.

Be it ordained by the Council of the Village of Spencer, Medina County, Ohio three-fourths of its members concurring herein as follows:

SECTION 1:

The salary of the Mayor of the Village of Spencer shall be \$900.00 per annum, payable semi-annually, term starting before December 31, 1975.

SECTION 2:

The salary of the Mayor of the Village of Spencer shall be \$1,200.00 per year, payable semi-annually, term starting after January 2, 1976.

SECTION 3:

The salary of the Clerk-Treasurer of Council of the Village of Spencer shall be \$800.00 per annum, payable semi-annually.

SECTION 4:

The salary of the Clerk-Treasurer of the Board of Trustees of Public Affairs shall be \$1,700.00 per annum, payable semi-annually.

SECTION 5:

The salary of the Councilmen of the Village of Spencer shall be \$150.00 payable semi-annually, terms starting before December 31, 1975.

SECTION 6:

The salary of the Councilmen of the Village of Spencer shall be \$200.00 payable semi-annually, terms starting after January 2, 1976.

SECTION 7:

The Salary of the members of the Board of Trustees of Public Affairs shall be \$150.00 per annum, payable semi-annually, terms starting before December 31, 1975.

SECTION 8:

The salary of the members of the Board of Trustees of Public Affairs shall be \$200.00 per annum, payable semi-annually, terms starting after January 2, 1976.

SECTION 9:

The salary of the Village Solicitor shall be \$100.00 per quarter year, payable quarterly for the attendance at the regular Council meeting, and \$35.00 per hour for other services rendered.

SECTION 10:

The salary of the Superintendent of the Water Plant and the Water Distribution System shall be \$6,488.10 per annum, payable semi-monthly.

SECTION 11:

The salary of the Superintendent of the Sanitary Sewer System shall be \$5,546.50 per annum, payable semi-monthly.

SECTION 12:

The salary of the collector of water and sewer rents shall be \$480.00 per annum, payable semi-annually.

SECTION 13:

The salary of the Village Street and maintenance Superintendent shall be \$ 9,000.00 per year, payable weekly.

SECTION 14:

The salary of the Superintendent of Parks shall be \$3.25 per hour for each hour of service rendered, payable monthly.

SECTION 15:

The salary of the Chief of Police for the Village of Spencer shall be 11,000.00 per annum, payable weekly.

SECTION 16:

The pay schedule for part time Patrolmen for the Village of Spencer shall be as follows:

<u>Time of Service</u>	<u>Hourly Wage</u>
0 - 6 months	\$2.50 per hour
6 - 12 "	2.75 " "
12 - 18 "	3.00 " "
18 - 24 "	3.25 " "
24 - or more	3.50 " "

payable monthly

SECTION 17:

The maximum wage to be paid to all other employees of the Village of Spencer, including employees of the Park, Street, Water, and Sewer Departments shall be \$2.65 per hour, payable monthly on due presentment of invoices approved and presented to the Village Clerk by Dept. Head.

SECTION 18:

This ordinance is hereby declared to be an emergency measure in that it provides for the payment of salaries and wages to Village employees, thereby assuring to the residents of the Village of Spencer, a constant and uninterrupted service from all Village Dept., thereby preserving the public health, peace, and safety and shall take effect and be in full force immediately upon its passage, providing it shall receive the affirmative vote of three-fourths of all members elected to Council, otherwise it shall take effect and be in force from and after the earliest period allowed by law, and repealing all previous Ordinances passed for setting of pay schedules.
