

ORDINANCE NO. // -81

AN ORDINANCE FIXING THE MAXIMUM SALARY AND OR WAGES OF THE OFFICIALS AND EMPLOYEES OF THE VILLAGE OF SPENCER, OHIO EFFECTIVE JANUARY 1, 1982 AND DECLARING AN EMERGENCY

BE IT ORDAINED, by the Council of the Village of Spencer, Medina County, Ohio three-fourths of its members concurring herein as follows:

SECTION 1: The salary of the Mayor of the Village of Spencer shall be \$1,300.00 per annum, payable semi-annually, for terms starting on or after January 1, 1981.

SECTION 2: The salary of the Clerk-Treasurer of the Village of Spencer Council shall be \$1,300.00 per annum, payable semi-annually for terms starting on or after January 1, 1981.

SECTION 3: The salary of the Clerk-Treasurer of the Board of Trustees of Public Affairs shall be \$2,200.00 per annum, payable semi-annually, for terms starting on or after January 1, 1981.

SECTION 4: The salary of the Council members of the Village of Spencer shall be \$250.00 per annum, payable semi-annually for terms starting on or after January 1, 1981.

SECTION 5: The salary of the members of the Board of Trustees of Public Affairs shall be \$250.00 per annum, payable semi-annually for terms starting on or after January 1, 1981.

SECTION 6: The salary of the Village Solicitor shall be \$50.00 for each regular council meeting attended, payable quarterly plus an amount of \$45.00 per hour for all work done outside of regular council meetings and additional expenses incurred by Solicitor in carrying out his duties.

SECTION 7: The salary of the Superintendent of the Water Plant and the Water Distribution System shall be \$8,741.25 per annum, payable semi-monthly, plus \$125.00 clothing allowance.

SECTION 8: The salary of the Superintendent of the Sanitary Sewer System shall be \$7,470.75 per annum, payable semi-monthly, plus \$125.00 clothing allowance.

SECTION 9: The salary of the collector of water and sewer rents shall be \$660.00 per annum, payable semi-annually.

SECTION 10: The salary of the Village Street and Maintenance Superintendent shall be \$14,520.00 per year, payable weekly, plus \$250.00 clothing allowance.

SECTION 11: The salary of Park and Construction Supervisor shall be \$1,500.00 per year payable weekly.

SECTION 12: The salary of the Superintendent of Parks shall be on a per hour basis for each hour of service rendered, payable monthly, as follows:

0- 1 ^{years} hour	\$3.50 per hour
1- 2 ^{years} hours	\$4.00 per hour
Over 2 ^{years} hours	\$4.25 per hour

SECTION 13: The salary of the Chief of Police for the Village of Spencer shall be \$16,968.00 per annum payable weekly, plus \$250.00 uniform allowance.

SECTION 14: The pay schedule for part time Patrolmen for the Village of Spencer shall be as follows:

TIME OF SERVICE

HOURLY WAGE

0 to 1 year	\$ 3.75
1 to 2 years	\$ 4.00
Over 2 years	\$ 4.75

payable montlyly, plus standard uniform allowance of \$120.00

SECTION 15: The maximum wage to be paid to all other employees of the Village of Spencer, including employees of the Park, Street, Water and Sewer Departments shall be \$3.50 per hour, payable monthly on due presentment of invoices approved and presented to the Village Clerk by Department head.

SECTION 16: The salary of the parttime Dispatcher for the Village of Spencer shall be \$4.25 per hour, payable weekly.

SECTION 17: This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare and for the particular reason that it provides for the payment of salaries and wages to Village employees thereby assuring to the residents of the Village of Spencer a constant and uninterrupted service from all Village Departments, and it shall take effect and be in full force immediately upon its passage.
