

ORDINANCE NO. 3 -81

AN ORDINANCE AUTHORIZING AND DIRECTING
A CONTRACT WITH BOCK & CLARK FOR
PROFESSIONAL ENGINEERING SERVICES
AND DECLARING AN EMERGENCY

BE IT ORDAINED, by the Council of the Village of
Spencer, Ohio, three fourths of its members concurring
herein, as follows:

1. That the proposed contract between the Village
of Spencer and Bock & Clark for professional engineering
services which is attached hereto and made a part hereof
is approved and the Mayor and the Clerk are hereby authorized
and directed to execute said contract on behalf of the
Village of Spencer, Ohio.

2. Payments for said professional services are hereby
appropriated and shall be paid by the Clerk from the
appropriate village funds.

3. This Ordinance is hereby declared to be an emergency
measure necessary for the public peace, health, safety and
welfare of the Village of Spencer and for the particular
reason that it is immediately necessary to retain these
services of a professional engineer so as to get under way
needed village projects and that this Ordinance shall be in
full force and effect from and after its passage.
