
**AN ORDINANCE AUTHORIZING THE MAYOR AND
CLERK TO ENTER INTO CONTRACT WITH
WILLOWVALE FARMS, INC. FOR THE PURCHASE
OF STONE AND DECLARING AN EMERGENCY**

BE IT ORDAINED by the Council of the Village of
Spencer, Medina County, Ohio, three-fourths (3/4) of its members
concurring herein as follows:

1. That the Mayor and Clerk of the Village of Spencer
are hereby authorized to enter into agreement with Willowvale
Farms, Inc. for the purchase of #304, #411, #8, #57, and #67
stone pursuant to the terms of the written proposal attached
hereto and incorporated herein as "Exhibit A"; and

2. That this Ordinance is hereby declared to be an
emergency measure necessary for the preservation of the health,
safety, and welfare of the Village of Spencer, Ohio, and for the
specific reason that the purchase of stone is necessary for the
construction of the two (2) parking lots and walk trail at the
J. B. Firestone Park during the current warm weather, building
season, and that this Ordinance shall be in full force and effect
from and after its passage.
