

ORDINANCE NO. 8-02


AN ORDINANCE AUTHORIZING THE MAYOR AND  
CLERK TO ENTER INTO CONTRACT WITH  
DON KOSTECKI EXCAVATING FOR THE EXCAVATION  
OF TWO PARKING LOTS AND THE WALKING  
PATH AT THE J. B. FIRESTONE PARK AND  
DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the Village of  
Spencer, Medina County, Ohio, three-fourths (3/4) of its members  
concurring herein as follows:

1. That the Mayor and Clerk of the Village of Spencer  
are hereby authorized to enter into agreement with Don Kostecki  
Excavating for the construction of two (2) parking lots and a  
walking path at the J. B. Firestone Park pursuant to the terms of  
the written proposal attached hereto and incorporated herein as  
"Exhibit A"; and

2. That this Ordinance is hereby declared to be an  
emergency measure necessary for the preservation of the health,  
safety, and welfare of the Village of Spencer, Ohio, and for the  
specific reason that the parking lot excavation and construction  
need to be completed constructed during the current warm weather,  
building season, and that this Ordinance shall be in full force  
and effect from and after its passage.


