

**ORDINANCE NO. 10-02 ✓**

**AN ORDINANCE AUTHORIZING THE MAYOR AND  
CLERK TO ENTER INTO CONTRACT WITH  
RICHLAND SEALCOATING COMPANY, INC.  
FOR CRACK SEALING ON LORAIN, JEFFERSON,  
LIBERTY, RAINBOW, STUART, SCHOOL, AND JACKSON  
STREETS AND CRACK SEALING ON STATE ROUTE  
301 FROM CORPORATION LIMIT SIGN TO  
CORPORATION LIMIT SIGN AND  
DECLARING AN EMERGENCY**

BE IT ORDAINED by the Council of the Village of  
Spencer, Medina County, Ohio, three-fourths (3/4) of its members  
concurring herein as follows:

1. That the Mayor and Clerk of the Village of Spencer  
are hereby authorized to enter into agreement with Richland  
Sealcoating Company, Inc. for crack sealing on Lorain, Jefferson,  
Liberty, Rainbow, Stuart, School and Jackson Streets, and crack  
sealing on State Route 301 from Corporation limit sign to  
Corporation limit sign pursuant to the terms of the written  
agreement attached hereto and incorporated herein as "Exhibit A";  
and

2. That this Ordinance is hereby declared to be an  
emergency measure necessary for the preservation of the health,  
safety, and welfare of the Village of Spencer, Ohio, and for the  
specific reason that the crack sealing needs to be completed on  
the above-named streets during the current warm weather, building

season, and that this Ordinance shall be in full force and effect from and after its passage.
