

**ORDINANCE NO. 11-02**

**AN ORDINANCE DETERMINING TO PROCEED WITH  
THE IMPROVEMENT OF MIDDLE JACKSON  
STREET AND DECLARING AN EMERGENCY**

WHEREAS, this Council did duly adopt Resolution No. R-10-01 on the 23<sup>rd</sup> day of May, 2001, declaring therein the necessity of the proposed improvements hereinafter described; and

WHEREAS, pursuant to said Resolution, estimated assessments with respect to said improvements were duly prepared and placed on file in the office of the Clerk of this Council and notices of same were served in accordance with law; and

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Spencer, Ohio, three-fourths (3/4) of its members concurring herein as follows:

1. That it is hereby determined to proceed with the improvement of Middle Jackson Street between Washington and West Centerville Streets by installing pavement, sidewalks, storm sewers, and appurtenances in accordance with the approved provisions of said Resolution No. R-10-01 and in accordance with the plans, profiles, specifications, and the estimate of cost for said improvements heretofore approved and filed in the office of the Clerk of this Council.

2. That the estimated assessments of the cost of said improvements heretofore prepared and filed in the office of said Clerk be and the same hereby are adopted.


3. That it is further determined that the portion of the cost of said improvements to be assessed against the

benefited property shall be assessed in the amount, manner, and number of installments as provided for in said Resolution declaring the necessity of said improvements.

4. That the Clerk of the Village is hereby authorized and directed to advertise for bids for the construction of said improvements in the manner provided by law and subject to the provisions of Ohio Revised Code § 727.24 and the availability of funds, the Village shall enter into a contract for said improvements with the lowest and best bidder.

5. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of said Village and for the particular reason that it is necessary to obtain immediate bids in order to construct the improvements during the current building season, and therefore this Ordinance shall be in full force and effect from and after its passage.
