**AN ORDINANCE AUTHORIZING THE MAYOR AND
CLERK TO ENTER INTO CONTRACT WITH
F&H BLACKTOP SEALING FOR THE SEALING OF
CONCRETE CURB JOINTS ON SCHOOL, JEFFERSON,
AND JACKSON STREETS, THE TOUCH UP OF CONCRETE
CURB JOINTS ON STATE ROUTE 301, POT HOLE
PATCHING ON ALL STREETS IN THE VILLAGE,
AND RE-PATCHING OF THE TRENCH IN THE ROAD
J. B. FIRESTONE PARK AND DECLARING AN EMERGENCY**

BE IT ORDAINED by the Council of the Village of
Spencer, Medina County, Ohio, three-fourths (3/4) of its members
concurring herein as follows:

1. That the Mayor and Clerk of the Village of Spencer
are hereby authorized to enter into agreement with F&H Blacktop
Sealing for the sealing of concrete curb joints on School,
Jefferson, and Jackson Streets, the touch up of concrete curb
joints on State Route 301, the pot hole patching on all streets
in the Village, and the re-patching of the trench in the road at
J. B. Firestone Park pursuant to the terms of the written
proposal attached hereto and incorporated herein as "Exhibit A";
and

2. That this Ordinance is hereby declared to be an
emergency measure necessary for the preservation of the health,
safety, and welfare of the Village of Spencer, Ohio, and for the
specific reason that the work described hereinabove needs to be
completed during the current warm weather, building season, and

that this Ordinance shall be in full force and effect from and after its passage.

We are looking to get started on the curb sealing and patching on or around April 8th depending on weather conditions and if the asphalt plants are open.
