

## **ORDINANCE NO. 6-11**


**AN ORDINANCE DETERMINING THAT REMOVAL AND REPLACEMENT OF THE STORM SEWER, TOGETHER WITH NECESSARY APPURTENANCES, ON NORTH MAIN STREET SHOULD BE MADE, ACCEPTING THE LOWEST AND BEST BID FOR SAID IMPROVEMENTS, AUTHORIZING THE MAYOR AND THE VILLAGE FISCAL OFFICER TO ENTER INTO A CONTRACT WITH THE SUCCESSFUL BIDDER FOR SAID IMPROVEMENT, AUTHORIZING PAYMENT OF THE CONTRACT PRICE FROM THE APPROPRIATE FUND AND DECLARING AN EMERGENCY**

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Spencer, Ohio, three-fourths (3/4) of its members concurring herein as follows:

1. That the improvement of North Main Street by way of removing and replacing the storm sewer in the Village of Spencer, together with necessary appurtenances, should be made in accordance with the plans and specifications on file in the office of the Village Fiscal Officer of this Village Council;
2. That the bid of Mark Haynes Construction, Inc., in the amount of Sixty-three Thousand Eight Hundred Twenty-two and 00/100 Dollars (\$63,822.00) is hereby declared to be the lowest and best bid and is accepted by the Village of Spencer;
3. That the Mayor and the Village Fiscal Officer are hereby authorized and directed to enter into a contract with the successful bidder on a contract form approved by the Village Solicitor;
4. That the contract price is hereby appropriated and shall be paid from the J. B. Firestone Trust Fund 2902 in accordance with said contract.
5. That this Ordinance is hereby determined to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of said Village and for the

particular reason that it is immediately necessary to accept such bid and enter into a contract with a successful bidder in order to take advantage of the best and lowest bid and to commence work on improvements as soon as practical during the current building season, and that this Ordinance shall be in full force and effect from and after its passage.


