

ORDINANCE NO. 16-17

AN ORDINANCE DETERMINING THAT IMPROVEMENTS TO THE WATER LINE ON SOUTH MAIN STREET FROM PARK DRIVE TO OLD MILL ROAD BY WAY OF INSTALLATION OF APPROXIMATELY 3,500 FEET OF EIGHT-INCH WATER LINE, TOGETHER WITH OTHER NECESSARY APPURTENANCES, SHOULD BE MADE, ACCEPTING THE LOWEST AND BEST BID FOR SAID IMPROVEMENTS, AUTHORIZING THE MAYOR AND THE VILLAGE FISCAL OFFICER TO ENTER INTO A CONTRACT WITH THE SUCCESSFUL BIDDER FOR SAID IMPROVEMENT, AUTHORIZING THE PAYMENT OF THE CONTRACT PRICE FROM THE APPROPRIATE FUND AND DECLARING AN EMERGENCY


NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Spencer, Ohio, three-fourths (3/4) of its members concurring herein as follows:

1. That the improvement of the water line on South Main Street from Park Drive south to Old Mill Road by way of installation of approximately three thousand five hundred feet (3,500') of eight-inch (8") water line, together with all other necessary appurtenances, should be made in accordance with the plans and specifications on file in the office of the Village Fiscal Officer of this Village Council;
2. That the bid of B K Layer, LLC, in the amount of Two Hundred Seventy-four Thousand Four Hundred Thirty-three Dollars (\$274,433.00) is hereby declared to be the lowest and best bid and is accepted by the Village of Spencer;
3. That the Mayor and the Village Fiscal Officer are hereby authorized and directed to enter into a contract with the successful bidder on a contract form approved by the Village Solicitor;
4. That the contract price is hereby appropriated and Two Hundred Thousand and 00/100 Dollars (\$200,000.00) shall be paid with loan proceeds from the Ohio Water


Development Authority and Seventy-four Thousand Four Hundred Thirty-three and 00/100 Dollars (\$74,433.00) shall be paid from the Water Fund 5101 in accordance with said contract.

5. That this Ordinance is hereby determined to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of said Village and for the particular reason that it is immediately necessary to effectuate improvements to the subject water line as soon as practical during the current building season, and that this Ordinance shall be in full force and effect from and after its passage.


