

ORDINANCE NO. 257

AN ORDINANCE FIXING THE MAXIMUM SALARY AND/OR WAGES OF THE OFFICIALS AND EMPLOYEES OF THE VILLAGE OF SPENCER, MEDINA COUNTY, OHIO EFFECTIVE JANUARY 1, 1973 AND DECLARING AN EMERGENCY.

Be it ordained by the Council of the Village of Spencer, Medina County, Ohio:

SECTION 1:

The salary of the Mayor of the Village shall be \$900.00 per annum payable semi-annual.

SECTION 2:

The salary of the Clerk-Treasurer of the Village shall be \$700.00 per annum payable semi-annual.

SECTION 3:

The salary of the Clerk of the Board of Trustees of Public Affairs shall be \$1,300.00 per annum payable semi-annual.

SECTION 4:

The salary of all Councilmen with terms of office commencing prior to January 1, 1972 shall be \$120.00 per annum payable semi-annual.

SECTION 5:

The salary of all Councilmen with terms of office commencing after January 1, 1972 shall be \$150.00 per annum payable semi-annual.

SECTION 6:

The salary of the members of the Board of Trustees of Public Affairs with terms commencing prior to January 1, 1972 shall be \$100.00 per annum payable semi-annual.

SECTION 7:

The salary of the members of the Board of Trustees of Public Affairs with terms commencing after January 1, 1972 shall be \$150.00 per annum payable semi-annual.

SECTION 8:

The salary of the Village Solicitor shall be \$75.00 per Quarter year, payable quarterly for attendance at the regular council meetings and \$20.00 per hour for all other services rendered.

SECTION 9:

The salary of the Superintendent of the Water Distribution System shall be \$4,500.00 per annum, payable semi-monthly.

SECTION 10:

The salary of the Technical Supervisor of the Water Plant and Distribution System shall be \$900.00 per annum, payable monthly.

SECTION 11:

The salary of the Supervisor or Superintendent of the Sanitary Sewage Collection System shall be \$3,700.00 per annum, payable semi-monthly.

SECTION 12:

The salary of the Technical Supervisor of the Sewer Plant and the Sanitary Sewage Collection System shall be \$900.00 per annum payable monthly.

SECTION 13:

The salary of the collector of water and sewer rents shall be \$360.00 per year, payable semi-annually.

SECTION 14:

The salary of the Fire Chief of the Village of Spencer shall be \$350.00 per annum payable semi-annually.

SECTION 15:

The compensation of volunteer village firemen, not to exceed thirty (30) in number, when needed, shall be as follows, and shall be payable semi-annually.

A. \$2.50 per hour, for each hour consumed while on call.

B. \$1.00 per meeting for each meeting attended, not to exceed 12.

SECTION 16:

The compensation for the village Police shall be as Follows:

A. \$2.75 per hour for the Chief of Police while on duty.

B. \$2.50 per hour all Patrolmen while on duty.

SECTION 17:

The maximum wages to be paid to all other employees of the Village of Spencer, including employees of the park, street, water, and sewer departments shall be \$2.25 per hour payable monthly on due presentment of invoices approved and presented to the Village Clerk by dept. head.

SECTION 18:

This ordinance is hereby declared to be an emergency measure in that it provides for the payment of salary and wages to Village employees thereby assuring to the residents of the Village of Spencer a constant and uninterrupted service from all Village Depts. thereby preserving the public hearth, peace, and safety and should take effect and be in force immediately upon its passage, providing it shall receive the affirmative vote of two-thirds of all members elected to Council, otherwise it shall take effect and be in force from and after the earliest period allowed by law, and the repealing of Ordinance # 236, passed December 16, 1971.
