ACCEPTING THE PLAT OF STUART'S PLAT OF SUBDIVISION
OF 8.04 ACRES IN OUTLOT No. 8, TOWNSHIP LOT 3, SEC-
TION 13, SPENCER VILLAGE, SPENCER TOWNSHIP, MEDINA
COUNTY, OHIO.

Be It Resolved by the Village of Spencer:

SECTION I.

That the Plat of Stuart's Plat of Subdivision of 8.04
acres in Out Lot 8, Township Lot 3, Section 13, Spencer Village,
Spencer Township, Medina County, Ohio, be, and the same is hereby
approved and accepted and that the dedication to public use of
the street shown thereon be and the same is hereby accepted and
confirmed subject, however, to the following provisions:

- (a) That the Owner and Subdivider of
said Allotment shall provide a road passable to
traffic in all weather, containing a base of
stone and/or gravel. The traveled portion of
said road to be Eighteen (18) feet in width.
- (b) That the Owner and Subdivider of said
Allotment shall grade said street to grade to be
approved by the Village of Spencer.
- (c) That the Owner and Subdivider of
said Allotment shall grade said road so that a de-
pression or ditch for surface water shall run
along each side of the traveled portion of said
road.

SECTION II.

That this Resolution shall be in force and take effect
at the earliest possible date allowed by law.

ACCEPTING THE PLAT OF KENT FIRESTONE'S REPLAT
OF SUBLOTS NUMBERS 83, 84, 85, 86 and 87, CEN-
TERVILLE PLAT, SPENCER VILLAGE, SPENCER TOWN-
SHIP, MEDINA COUNTY, OHIO, AND DEDICATION OF
THE STREETS SHOWN THEREON.

Be It Resolved by the Village of Spencer:

SECTION I.

That the Plat of Kent Firestone's Replat of Sublots
Numbers 83, 84, 85, 86 and 87, Centerville Plat, Spencer Village,
Spencer Township, Medina County, Ohio, be and the same is hereby
approved and accepted and that the dedication to public use of
the street shown thereon be and the same is hereby accepted and
confirmed subject, however, to the following provisions:

- (a) That the Owner and Subdivider of said
Allotment shall provide a road passable to traffic
in all weather, containing a base of stone and/or
gravel. The traveled portion of said road to be
Eighteen (18) feet in width.
- (b) That the Owner and Subdivider of said
Allotment shall grade said street to grade to

Allotment shall grade said road so that a depres-
sion or ditch for surface water shall run along
each side of the traveled portion of said road.
