

**1 RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX IN EXCESS OF THE TEN MILL LIMITATION (All Taxing Units - General Election Only)**

Mr. Ternes \_\_\_\_\_ moved the adoption of the following Resolution:

WHEREAS, The amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said <sup>3</sup> \_\_\_\_\_ Village of Spencer \_\_\_\_\_ Medina \_\_\_\_\_ County, Ohio; therefore, be it

RESOLVED, By the <sup>2</sup> \_\_\_\_\_ Council \_\_\_\_\_ of the Village of Spencer \_\_\_\_\_ Medina \_\_\_\_\_

County, Ohio, two-thirds of all members elected thereto concurring, that it is necessary to levy <sup>4</sup> \_\_\_\_\_ an additional \_\_\_\_\_ tax in excess of the ten mill limitation for the benefit of \_\_\_\_\_ Village of Spencer \_\_\_\_\_ (Name of Subdivision)

for the purpose of <sup>6</sup> providing and maintaining motor vehicles, communications, and other equipment used directly in the operation of a police department, or the payment of salaries of permanent police personnel, including the payment of the policemen employer's contribution required under section 742.33 of the Revised Code

at a rate not exceeding two \_\_\_\_\_ mills for each one dollar of valuation, which amounts to \_\_\_\_\_ Twenty cents (\$0.20) \_\_\_\_\_ for each one hundred dollars of valuation for (Rate expressed in dollars and cents)

\*RESOLVED, That said levy be placed upon the tax lists of the current tax year in compliance with the provisions of Sec. 5705.34, \_\_\_\_\_ ~~after the February 1st election next succeeding the election~~, if <sup>7</sup> \_\_\_\_\_ a majority \_\_\_\_\_ of the electors voting thereon vote in favor thereof; and, be it further

RESOLVED, That the Clerk of this <sup>2</sup> \_\_\_\_\_ Council of the Village of Spencer \_\_\_\_\_ be and he is hereby directed to certify a copy of this Resolution to the Board of Elections, \_\_\_\_\_ Medina \_\_\_\_\_ County, Ohio, not less than seventy-five days before a general election and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.<sup>8</sup>
