

RESOLUTION R-2-86

A RESOLUTION BY THE COUNCIL OF THE VILLAGE OF SPENCER,
OHIO TO DECLARE ITS INTENTION TO APPROPRIATE FOR STORM
SEWER AND STREET IMPROVEMENT PURPOSES PERMANENT AND
CONSTRUCTION EASEMENTS

BE IT RESOLVED, by the Council of the Village of Spencer, Ohio as
follows:

1. This Council hereby deems it necessary and declares its intention
to appropriate for storm sewer, surface water retention and street improvement
purposes permanent and construction easements in and to the premises described
in Exhibits A through G, attached hereto and made a part hereof.

2. The Mayor is hereby authorized and directed to cause written notice
of the passage of this Resolution to be given to the owners, persons in
possession or having an interest of record in the above described premises
and said notice shall be served according to law by a person designated for
that purpose by the Mayor and such person shall make return of the service
of notice in the manner provided by law.
