AND TO DECLARE AN EMERGENCY


BE IT RESOLVED by the Council of the Village of Spencer, Ohio,

Three-fourths (¾) of its members concurring herein, as follows:


1. That request is hereby made to the Medina County Auditor for payment of all funds
