

RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX IN EXCESS OF THE TEN MILL LIMITATION

The ² Spencer Village of Medina County, Ohio, met in special session on the 19th day of July, 2005, at the office of the Spencer Village Council with the following members present:

Ms. Beverly Zeigler moved the adoption of the following Resolution:

WHEREAS, The amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said

Village of Spencer, Medina County, Ohio; therefore be it

RESOLVED, by the Council of the Village of Spencer, Medina County, Ohio, two-thirds of all members elected thereto concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of the Village of Spencer

for the purpose of providing and maintaining motor vehicles, communications, and other equipment used directly in the operation of a police department, and payment of personnel of the Spencer Village Police Department,

at a rate not exceeding 4.0 mills for each one dollar of valuation, which amounts to forty cents (\$.40)

for each one hundred dollars of valuation, for a continuing period of time and which levy is an additional 4.0 mills.
