A RESOLUTION OF THE VILLAGE OF SPENCER, OHIO,
AUTHORIZING AND EMPOWERING THE APPLICATION
FOR FUNDING UNDER THE OHIO DEVELOPMENT
SERVICES AGENCY, CDBG WATER & SEWER
GRANT FUND

WHEREAS, the Village of Spencer, Ohio, is in the process of applying for CDBG funding;

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Spencer, Ohio, three-fourths (3/4) of its members concurring herein as follows:


