provides long-term support and resources that promote mental health care and wellness for victims' families, responders, survivors, and families of those who have died of 9/11 related illnesses; and assists communities in preparing for and recovering from tragedy. For nearly 20 years, VOICES has helped tens of thousands of people – not only those impacted by 9/11, but other tragedies as well, including the pandemic. As its mission expanded, so too has its programming, education and training, including conferences and symposiums, both in the U.S. and abroad.

This year commemorates the 21st anniversary of that tragic day, **September 11, 2001. VOICES 21st** Annual Symposium themed *Pathway to Resilience* will address topics that are relevant to the 9/11 community such as:

- International and national security
- Law enforcement, victims' services
- Victim's Compensation Fund (VCF)
- Mental Health
- Investigations in the aftermath of 9/11
- Other acts of mass violence

VOICES is fortunate to have longstanding partnerships with subject matter experts and national and international organizations working in the field of victims' services, social services, mental health, public health and emergency preparedness. Collectively they have a shared vision, to create a world where victims' families and communities impacted by tragedy have the immediate and long-term support they need to ensure healing and resilience in their lives. For this year's Symposium, VOICES has garnered a group of highly distinguished professionals, in partnership with the Leadership in Counter Terrorism Alumni Association (LinCT-AA) and the International Network Supporting Victims of Terrorism and Mass Violence (INVICTM), to educate and advocate against terrorism around the world.

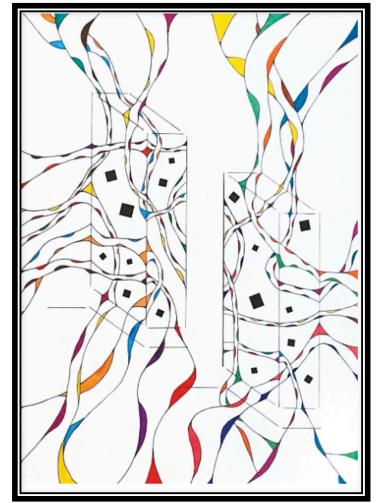

Building Trust During Turbulent Times 9:00 a.m. to 4:30 p.m. (Live Stream Only)

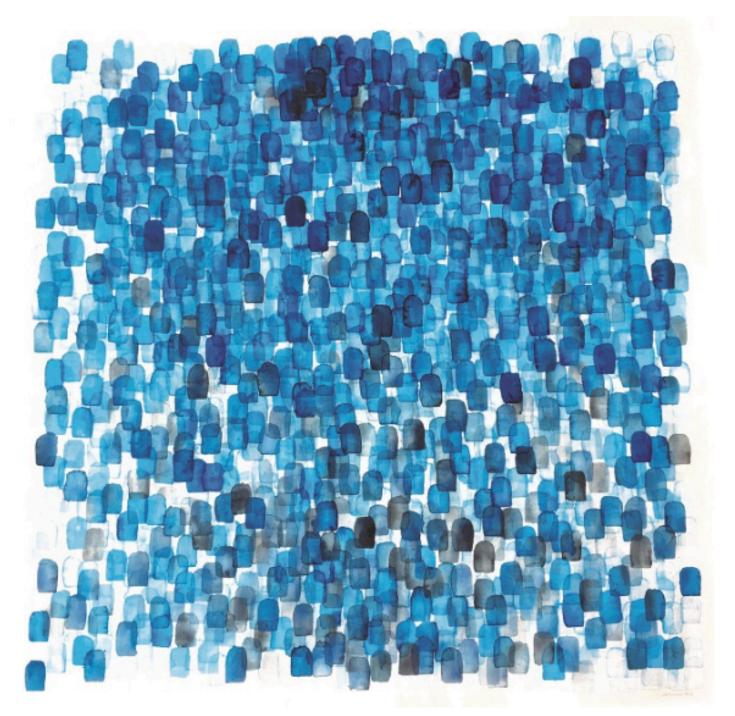

9/11 Commission Documentary Discussion 6:00 p.m. to 7:15 p.m. (Live Stream Only)

The September 9 Symposium is followed by an evening panel discussion about the 9/11 Commission and highlights of Are We Safer Today? The documentary chronicles the memories and observations of the 9/11 Commissioners on the largest investigation in US history that led to sweeping intelligence reforms. The conversation will also reflect on our Nation's progress towards implementing their recommendations as they commemorate twenty years since their formation.

The program features lessons learned for professionals and agencies providing victims' services and responding to other acts of mass violence.



DO YOU HAVE A 9/11 VICTIM'S CLAIM?

The **September 11th Victim Compensation Fund** also referred to as the **Zadroga 9/11 Health and** <u>Compensation Act</u> was established by an act of Congress to provide compensation for individuals who suffered a physical illness, injury or death as a result of the terrorist-related crashes into the World Trade Center on September 11, 2001, and its aftermath.

Compensation is now available to anyone who was present in lower Manhattan for some period of time, for any reason, in the months following September 11, 2001, even those who first returned to the area in early 2002.
