2025 CAMPGROUND POLICIES & REGULATIONS FOR THE SWISS WINE FESTIVAL

DATES:

Tuesday, August 21st Wednesday, August 20th Thursday, August 21st Friday, August 22nd Saturday, August 23rd

- SETUP: Beginning at 8:00 am on Tuesday, August 21st, 2025. (Please, no early set up).
- DEADLINE: August 1, 2025 (After August 1, space will be available to the next person on the waiting list).
- Applications will only be accepted for persons 18 years of age or older who will be camping in the space provided and who will be the responsible party.
- NO VERBAL, PHONE OR VOICE MAIL APPLICATIONS WILL BE ACCEPTED! No Exceptions.
- Subletting of campsite will not be permitted without prior approval of the Swiss Wine Festival, Inc.

 Use of the campsite by someone other than the "lessee" must be approved by the Swiss Wine Festival, Inc.
- All children under 12 years of age MUST have direct adult supervision while in the campground area. Parents will be held responsible for the actions of underage children.
- Only TWO (2) vehicles (This includes cars, trucks, or ATV's vehicles) may be parked in, or at, a camping site. Any more than 2 of the above vehicles must be parked in the festival parking lot. Any vehicle blocking traffic or fire lane will be towed at the owner's expense.
- Your assigned campground RV pass and your two (2) vehicle parking passes <u>MUST</u> always be displayed.
- Your assigned wristband MUST be worn by all the people always staying at your campsite.
- Visitors are welcome in the campground area, but they <u>MUST</u> enter the festival area through Gate 1, 2 or 3. Visitors <u>CANNOT</u> enter the campground area using the Washington Street Campground entrance.
- Beginning at Noon on Friday and continuing through Sunday at 4pm, only those vehicles displaying a valid Campground Parking Pass may be parked in the campground area. Police/Security will be monitoring the campground area. Vehicles without a valid Campground parking pass will be towed at the owner's expense.
- Loud noise and/or loud behavior will not be tolerated. Police/Security will monitor the campground area. Any person in violation of this rule may be asked to leave the campground and festival area. Let's all adhere to the good neighbor policy and try to work amongst yourselves to solve any problems you may have.
- The consumption of alcohol by minors <u>WILL NOT BE TOLERATED</u>. Immediate forfeiture of the campsite will occur with NO REFUND and the likelihood that campsite contract will not be issued in the future.
- The campground speed limit is 5mph. Vehicles observed violating this limit may be towed, and their owner will be asked to relinquish their camping privileges.

- There shall be NO pets or personal golf carts (insurance regulations) allowed in the festival area. These must be kept in the campground area unless prior permission has been given.
- Actions, which violate Local, State or Federal laws, will be considered as cause for immediate expulsion from the campground and possible arrest.
- The campground area must always be kept clean.
- No dumping of grey or black water. The use of portable showers, "solar showers", or any shower unit which is not completely self-contained is prohibited.
- The Swiss Wine Festival, Inc. reserves the right to banish any person or group of persons who violate the above rules and regulations.
- The Swiss Wine Festival reserves the right to modify the above rules and regulations at any time.
- SECURITY: The Swiss Wine Festival, Inc. is within the jurisdiction of the Switzerland County Sheriff's department. The Swiss Wine Festival, Inc. will provide some limited additional security in the festival area and campground area after hours. However, the Swiss Wine Festival, Inc. is not responsible for lost or stolen items, either during regular festival hours or after hours, under any circumstances. The Swiss Wine Festival, Inc. is not responsible for accidents or the acts of others.
- PLACEMENT: Assignment of campground sites is at the discretion of the Swiss Wine Festival Inc. In most cases you will be assigned the same camping site as last year, but there is no guarantee that you will have the same camping site as last year. Each application will be reviewed before the site assignment is made. Assigned campground sites cannot be changed without the approval of the Swiss Wine Festival, Inc.
- CONFIRMATIONS: Your campground packets (including all wristbands, passes, and parking passes) will be mailed after August 5, 2025. Please be sure to include your correct mailing address on your application.
- RENTAL AGREEMENT: The Camper agrees that the Swiss Wine Festival Inc. may revoke this agreement at any time and for any reason and that camper's damages will be limited to refund of the fee paid. Non-compliance of the rules as outlined in this agreement or in further written notices will result in immediate removal of camper with no refund due camper. This rental agreement is for campsite space only. The Swiss Wine Festival Inc. will not supply extension cords, tables, or other equipment. All rental agreements must be accompanied by payment in full. It is the camper's responsibility to read and understand all regulations as outlined in this rental agreement. The Swiss Wine Festival, Inc. is not responsible for accidents, damage, or loss of any kind. Trading or selling of a contracted camp site is strictly forbidden. This is to be the total contract. Any modifications shall be done in writing and approved by the Swiss Wine Festival, Inc. and camper. Indiana law shall be used to decide any disputes which may arise because of this contract.
