Saturday – Herdwork **Show #4** starts at 10 A.M., there will be no Wyoming High School Rodeo classes on Saturday.

Sunday – Reining/Fence/Box **Show #5 & #6** starts at 10 A.M., Sunday will include High School Rodeo classes. High School rodeo contestants' first run will be after the open class, the second high school run will be immediately after the CSSHA Youth Classes.

After a contestant has completed their reining pattern they may call for their cow to complete the fence run or boxing, if they did not enter the cow work they will exit the arena at that point. If a contestant just entered the cow work they will call for the cow as soon as they enter the arena.
