Our 2024 Accomplishments

Policy Advocacy



Hosted two successful fly-ins to engage Congress and administrative agencies, advancing biochar's role in carbon dioxide removal strategies and funding.

EPA Guidance



Played a key role in the U.S. EPA's decision to exclude clean cellulosic biomass used in biochar systems from classification as solid waste under the Clean Air Act.

OSWI Exemption



Ensured biochar systems are not subject to restrictive Other Solid Waste Incineration (OSWI) rules, bolstering industry growth.

Historic USDA Funding



Tracked \$7.7 billion in **USDA** conservation funding for 2025. including \$5.7 billion for climate-smart practices via the Inflation Reduction

Farm Bill Impact



Advocated for the inclusion of biochar in the largest single-year USDA conservation investment in U.S. history.

NRCS Collaboration



Engaged with NRCS during the Fall Fly-In to influence updates to Climate-Smart Agriculture and Forestry Mitigation Activities, now including 14 new practices.
