Meeting was called to order 7:05 p.m.

Motion to approve the June 17, 2025 board minutes by Matt Ksycki and 2<sup>nd</sup> by Sharon.

President Dertz advised we will let the vistors speak first.

Visitor – Heather Castillo – She wanted to let us know that they are having a Flea Market out of Marlin's Bar in Lyons, on Pershing and Harlem on August 17, 2025 from 1-6 p.m. She would like to donate the money they collect from the table space and entry fee to Chicagoland TFT. Bruce Weaver has the flyer. Bruce will follow up with her after a meeting. President Dertz is for it.

#### **Vice President: Sharon Choate**

She is looking into new warehouse space for the organization. She had one space, but it was rented out already. They have a new one and it is better. Foster and Sons is leaving the space and it should be ready in September. Would like as many board members to meet after the court hearing on July 16 at the space to view and give their opinion on it. It is \$2400 per month which is more than we pay now but it is larger and she is trying to work with the property manager to bring it down some.

Queen of Hearts was won by someone on July 10, 2025. The winner received \$2,581.00. Do we want to do another board? If so we will need to make a schedule up to have everyone participate and not the same people. Kim Allen said she can be there when Sharon can't be. Wanda said she can attend. We will wait until next meeting and then decide. We did purchase a new board already when we purchased the last board.

She received a phone call from the Forest Preserve about the Permit for December. Wanda said she is working on it.

She received a request to work with Larry Stotts, Safety Lawyers, also one of our members to send toys to Texas victims of the flooding. His firm will pay for the shipping. He would like to do this next week. He has a contact down there.

Oak Lawn library is looking for Hot Wheels used and new. We do have the Hot Wheels in the warehouse. A lot of them. We all agreed to donate some of them to the library.

We did receive the attorney invoice. Going through it, she is charging us for phone calls to Gene Nevins, one of our members and her cousin. Total bill is \$20,775.00. She says she is giving us a 50% discount or \$10,387.50. We paid her \$7,000 and owe \$3,087.50. Motion made by Sharon to pay the full invoice by end of August 2025. Matt 2<sup>nd</sup> it. All were in favor.

The use of our logo by Hot Dog. They have an Amazon account where they do a toy drive and they are using our logo. They can't use out logo without our permission. Matt will ask them to remove it from their flyer.

## Secretary: Wanda Perlinski

Member gifts still are not picked out. Sharon said that she received a 4 Imprint catalog and it has a 3 piece tote for \$9.00. She showed it on the video from the catalog and everyone agreed on it. Motion to approve the 3 piece tote made by Kim and 2<sup>nd</sup> by Sharon. All were in favor.

She asked President Dertz to keep an eye out for the check from the insurance company for the refund for the truck insurance. It was sent to P.O. Box 388500 instead of 288500. I asked them to stop and reissue to the correct box. They said it will take 10-15 days. The amount is \$1,615.00.

She has all three of the insurance dec pages for the run on Saturday with Devinity Funeral Homes. If she can't make the run she will send the insurance copies to Sharon.

She is working on filling out the application for the Forest Preserve and City of Chicago.

## **Treasurer: Sandy Scheel**

She wants to have Tara discuss with us and show us the new software that we will be using for our accounting.

Tara Wagner – She showed us the new system. It is \$14.25 a month. It will import bank statements every month. Every board member will have access to it. Should you get a new accountant in the future, it will be a seamless transition. The name of it is OLT PRO, Tax Software by Pistus. We will be able to do the taxes on time. A motion was made to approve to use the new system was made by Wanda and 2<sup>nd</sup> by Sharon. All were in favor. She will finish out the fiscal year, April 2025 in Quickbooks and then start using the new system for the May, 2025 information.

Sandy proceeded to go over the account balances.

Went over all the statements. Everyone agreed to the accuracy of the statements she provided us by e-mail.

She asked what the charge of \$2,440.00 to Centurain Promotions was for. Bruce said it was for the Ride Pins.

We will owe \$2500 for the Kick Off Party that night.

There was a gift card purchased for gas for a member that went to pick up toys and Mickey Mouse stuff that was donated to us.

Looking into foundations for donations and grants.
