Qualification Delivery

The recommended contact hours for this qualification is 18 hours, which includes direct teaching and assessing but excludes breaks.

The course may be run over 3-days, but can also be delivered over a maximum of a 10-week period, with the minimum of each training session being 2 hours

The ratio for this qualification is a maximum of 12 learners to 1 tutor.

Introduction

The STA First Aid at Work qualification forms part of the STA First Aid suite of qualifications. The qualification and learning outcomes are based on the recommendations of:

- First Aid Awarding Organisation Forum (FAAOF) Assessment Principles for First Aid Qualifications
- Resuscitation Council (UK).

The STA Level 3 Award in First Aid at Work qualification is designed for learners who deal with emergency first aid at work enabling them to be workplace emergency first aiders under the Health and Safety (First Aid) Regulations 1981 and The Health and Safety (First-Aid) Regulations (Northern Ireland) 1982.

Qualification Objective

The aim of the STA Level 3 Award in First Aid at Work qualification is to enable learners to develop the knowledge, understanding and skills that are required to deal with a range of first aid incidents including: basic life support, anaphylaxis, head and spinal injuries, asthma, bleeds and much more.

Target Learners

This qualification is for learners who have a specific responsibility at work to deliver basic first aid to individuals in a range of emergency first aid situations.

Progression

The STA Level 3 Award in First Aid at Work qualification enables learners to progress onto qualifications at the same level or above. It also allows industry professionals to maintain their continuous professional development and progress their careers.

Upon successful completion of this qualification learners may wish to pass on the knowledge and skills they have acquired through training as a first aid tutor / assessor.

- First Aid Awarding Organisation Forum Terms of Reference and Assessment Principles

Entry Requirements

Learners must be 16 years of age or above on the first day of the course. It is advisable that learners have a minimum of level 1 in literacy or numeracy or equivalent.

Learners must be able to kneel on the floor to deliver CPR.

Any Other Requirements / Requirements

This qualification is valid for a period of 3 years. The learner needs to retake the qualification before the certificate expiry date to remain qualified.

Health and Safety Executive (HSE) strongly recommends that first aiders undertake annual refresher training during any three-year FAW certification period. This will help qualified first aiders maintain their basic skills and keep up-to-date with any changes to first aid procedures.

Providing the learner's First Aid at Work certificate has not expired by more than 1 calendar month (e.g. expired on 5th, started course on or before 4th of the following month), the contact hours may be reduced to 12 hours over 2 days.

Learners must be assessed against all learning outcomes and assessment criteria in the units. To attend the shorter re-qualification course, learners should provide evidence of their previous FAW qualification.

Employers should be aware that if a workplace first aider's certificate expires, they will not be accepted as a first aider for the purposes of the First Aid at Work Regulations until they have re-taken the qualification.

Assessment Format

Pass / Fail

Assessment Methods

This qualification is tutor assessed through practical demonstrations and completion of a multiple-choice theory assessment paper.

All practical elements must be completed and performed independently by the learner without prompting by the tutor.

The multiple-choice assessment paper is to be completed independently by each learner and completed under exam conditions, with the tutor or other approved person, acting as the invigilator. Learners must achieve a minimum mark or higher to successfully pass the multi-choice assessment paper.

All learning outcomes and assessment criteria in the units must be achieved in order for the learner to be deemed competent in order to pass the qualification.

Assessors will assess no more than 4 learners at any one time when performing practical demonstrations.

Please refer to the STA First Aid at Work assessment strategy document for the detailed assessment process.

All tutors must have the skills, knowledge and experience to be able to teach and demonstrate the subject.

Each tutor must be approved by Safety Training Awards and provide evidence of:

- 1. A relevant vocational first aid qualification and / or experience as shown in Appendix 1
- 2. A formal tutoring and assessing qualification as shown in Appendix 2. Tutors must maintain their technical competence within the subject area and provide evidence of continuing professional development (CPD).

IQA Requirements

Internal Quality Assurers of this qualification must have knowledge and competency in first aid as well as knowledge and competency in internal quality assurance.

An Internal Quality Assurer must hold:

- 1. A relevant vocational first aid qualification and / or experience as shown in Appendix 1
- 2. Attend a STA / IQA training day or hold a recognised internal quality assurance qualification

Note: Internal Quality Assurers cannot quality assure a course for which they were a learner, the tutor and / or assessor.

Resource Requirements

Course resources:

• STA First Aid resource manual - Each learner is required to have their own copy of the resource manual to keep during and after the course, in order to have access to the theoretical knowledge of the qualification.

Venue:

- Room size: Adequate space for all learners on the course to undertake theory and practical work
- Seats: One per learner
- Writing surfaces: Adequate for each learner to take notes
- Toilets: Separate facilities for male and female learners
- Ventilation: Should be adequate
- Lighting: Should be suitable for reading, combining a mixture of natural and artificial light
- Heating: Should maintain a `short sleeve' environment, minimum temperature 16°C
- Entrances / exits: Should be safe, well lit and DDA compliant
- Floor coverings: Should be carpeted or mats / blankets provided for use during practical sessions
- Cleanliness: Maintain a clean, tidy and hygienic environment
- Noise: Consider whether there is noise that may distract learners from training.

Minimum requirements:

- Laptop
- PowerPoint presentation
- TV or other display method
- STA resource manual per learner
- Adult basic life support manikins ratio 1:4
- Resuscitation face shield or pocket mask.
- First Aid Kit
- AED trainer
- Auto-injector training device.

Recommended:

- Dry wipe board
- Flipchart
- Blankets.

Training packs (recommended):

Each registered learner to have access to the following training items during the course:

- 1 triangular bandage
- 1 medium sized sterile dressing
- 1 pair of disposable gloves
- 1 individually wrapped sterile adhesive dressing
- 1 resuscitation ventilation aid.

Equipment Service and Maintenance

Ensure all electrical equipment is in safe working order, serviced and maintained in line with statutory requirements, such as Portable Appliance Testing (PAT) and Provision and Use of Work Equipment Regulations (PUWER).

Follow manufacturers guidance on regular cleaning, service and ongoing maintenance requirements for all course equipment.

Sufficient procedures must be in place to ensure hygiene during the use of resuscitation manikins and other training equipment.

It is important to be aware of the trip hazards associated with electric cables and reduce such risks.

Appendix 1

Technical competence in first aid

All Tutors, Assessors and Internal Quality Assurers must have occupational knowledge and competence in first aid.

Acceptable evidence includes:

- Holding a current First Aid at Work Certificate (issued by an Ofqual / SQA / Qualifications Wales recognised Awarding Organisation or equivalent
- Current registration as a Doctor with the General Medical Council (GMC)
- Current registration as a Nurse with the Nursing and Midwifery Council (NMC)
- Current registration as a Paramedic with the Health and Care Professions Council (HCPC).
