- O Copy of registration. Only the owners listed on the registration can transfer the plate to the new vehicle. If not listed, new plates will be issued. Please be aware if the plate is switching plate class from lease to retail the metal impact fee will be charged automatically, \$225.
- O If the vehicle is pre-owned, a used car title, an original vehicle vin inspection is required. If vehicle is out of state, vin inspections can only be performed by an officer. If vehicle is in Florida, please review the form on whom can perform the inspection.
- O Original proof of Reciprocal Tax paid. This form can only be submitted if your state is reciprocal with the state of Florida. If not reciprocal, taxes are due at the time of registration.
- O Mama Bear Power of Attorney. This allows Mama Bear Tag & Title to legally execute reassignments on forms, titles, and/or MSO, affidavit of corrections and odometer on behalf of your dealership.
- O Original MSO or Use Car Title. Send any other supporting documents such as reassignment, affidavit, etc.
