Meeting called to order 4:30 pm - Quorum established.

President: Opening comments and welcoming members.

Approval of Agenda: Motion by L. Steuber; Second by J. Carrick. Motion passed.

Resident Comments: Questions asked if there will be a Christmas gathering by the Association. Approval of Minutes, both meeting 11/21/2019 and special meeting 12/5/2019 - Motion by L. Steuber; Second by L. Lofink. Motion passed.
