Approval of Agenda – Motion by L Steuber; Second by J, Carrick, Motion passed.

Approval of Minutes, meeting 4/25/2019 – Motion by Linda Lofink, Second by L. Steuber, Motion passed.

### **Action Items:**

- 1) Board Resolution No Parking on Common Areas/Towing (<u>Item Tabled pending further review/No action required</u>).
- 2) Bid for Fountains 1<sup>st</sup> Bid Shaw Irrigation \$17,310; 2<sup>nd</sup> Bid Lake Doctor-\$17,464; (Four bid packages sent; two completed bid packages received for consideration). Motion to approve 2<sup>nd</sup> bidder "Lake Doctor" in the amount of \$17,464.00 which covers electrical/boring requirement & two new fountains at main entry of community. Motion by L. Steuber; Second by J. Bartel, Motion passed.
- 3) Streets and Maintenance Approved \$1000; Motion by J. Bartel, Second by J. Carrick; Motion passed.
- 4) Assessing late fees & interest for past due assessments letter has been approved by the board already.

#### **Old Business:**

- 1) A suggested Disaster Recovery Plan is being drafted by J. Bartel. Board will need to determine what documents we have, where they are and what are required for retention purposes. Discussion of putting this plan on back up drives also somewhere on line. Hurricane Plan also discussed. (Discussion/information only)
- 2) Mail House Lease: Update provided; J. Carrick needs to get a survey of the area from flagpole to parking lot. A Special meeting will take place to finalize Lease which will be posted in the mail house & website when ready to be voted on. (Special Meeting Agenda Action Item 1.)
- 3) Amending Governing Documents We must have 51% of total voting interests. Which means: of the 246 total units, we will need 125 votes to move forward to amend the documents. Amendment 12 (as referenced in past Attorney prepared documents) will be placed on the agenda for vote at A Special meeting.
