## **OLD BUSINESS:**

1. Update on 19990 Petrucka Circle: Diane Z. made a motion and Linda L. second to suspend the rules of order. The motion passed.

Daniel Mora, the owner of the home in question, presented his case. He understood that the Violation Assessments Committee told him to could keep the ladder rack on his SUV.
