a. Police Report – Cherokee Co Sheriffs Dept., Lt. Anderson stated there was nothing to report but reminded residents to lock their vehicles and secure their valuables.

b. Mayor's Report – Mayor Green stated the city hired Mr. Evan Howell to clean up the tree debris on Hwy 5 due to safety concerns and the difficulty getting quotes from companies due to how busy they were. She updated the Council on the infrastructure project and stated they hope to begin by the end of July. She also advised the Movies in the Park will be rescheduled for sometime in Sept due to two prior cancellations because of weather issues.

c. Finance Report – Mrs. Miranda McDowell went over the current bank balances and where the city stands with the FY25 budget. She also stated the city will need to set the millage rate and hold a public hearing at a Special Called Meeting in July. The Council discussed and decided to hold the Special Called Meeting and Public Hearing for the millage rate on the Cherokee Co side of the city on July 24<sup>th</sup> at 7pm.
