- b. Building Permits Fee Schedule & Required Inspections Mayor Green stated the increases have been made to the building permit fee schedule to follow Pickens County's fee schedule. The minimum permit amount is \$100 and reinspections will be \$100. These changes will cover the inspection cost which is \$95 hour with a one-hour min. Mr. William Taylor made a motion to approve the revised fee schedule, Seconded by Mr. Nathan Taylor, All in favor, Vote unanimous...
- c. Updated Fire IGA Cherokee County Mayor Green stated the revisions were made to remove the fire tax from the Pickens Co side of the city (already paying a fire tax that is included with the county tax bill), the city will only collect the fire tax from the Cherokee Co side of the city. Mrs. Kristeen MacNeill made a motion to approved the revised Fire IGA with Cherokee Co., Seconded by Mr. William Taylor, All in favor, Vote unanimous...

a. Noise Ordinance Revisions – Attorney Jeff Rusbridge discussed the revisions to the city noise ordinance which will include fireworks. The Council and Mayor discussed the changes and the item will be on the Jan agenda after the legal ads are run in the local newspapers.
