The Illinois Youth Investment Program (IYIP) is a multi-faceted approach to youth employment that invests in the future of Illinois' youth ages 16 to 24. This approach to youth employment accounts for the youth's employment barriers as well as the physical, emotional, social, and mental health needs while helping them to secure and sustain long-term and/or career employment thereby ensuring a greater likelihood of success and self-sufficiency.

4b (Code:) (Expenses \$ 832,817. including grants of \$) (Revenue \$ 487,540.)

The Supplemental Nutrition Assistance Program (SNAP) (formerly Food Stamps) helps low-income people and families buy the food they need for good health. Benefits are provided on the Illinois Link Card - an electronic card that is accepted at most grocery stores. The program is managed by the Food and Nutrition Service (FNS) of the United States Department of Agriculture. The Department of Human Services administers the program in Illinois.

The Job Training and Economic Development (JTED) program is a grant-funded initiative that provides occupational training and support services to help individuals gain employment and meet the skill needs of target industries. It aims to address barriers to work for adults and youth by offering career development opportunities, such as work-based learning and skill-building, and by creating partnerships between employers and training providers. These programs can also offer flexible funding to help participants overcome barriers to employment, like costs for basic needs.
