The product is made from healthy fruits. It is food grade, free of additives, genetically modified organisms and allergens, produced and maintained according to HACCP / PRP principles.

Heavy metal residues and authenticity are in accordance with Code of Practice for Evaluation of Fruit and Vegetable Juices A.I.J.N. (European Fruit Juice Association).
