A. Services. CC Drivers JA will...

- Provide student with driving lessons (*based upon Lessons purchased*)
- Require driving lessons to be completed within 6 months of the student receiving their permit
- Provide a driving completion certificate (*based upon hours completed*)
- Allow parent observation (*Client must notify CC Drivers JA prior to the lesson*)
- Reschedule any lesson for bad weather, car failures, or other emergencies
- Only have one student in the car at a time \*

*\* Under this agreement, an instructor may not provide behind-the-wheel training to more than two individual students per session; however, it is the policy of CC Drivers JA that driving instruction is one on one (no other students in the car). If the client requires the student to be paired with another student, both clients must sign a waiver stating that the client is aware that their student will be in a vehicle driven by another student.*

B. Driving Lessons and Fees. Students must meet or be dropped off at CC Drivers JA designated locations for lessons or otherwise arranged. Lessons must be scheduled at least two or more lessons at a time. Fees for lessons are \$3500 per 45 minutes. Rescheduling lessons must be made at least 24 hours in advance.

C. Canceled/Missed Driving Appointment Fees. Parents/students will be charged a **\$500.00 appointment cancellation fee** if the student is more than 15 minutes late; does not show up; arrives without a valid learner's permit, is under the influence of any drugs or alcohol; drowsy; is not dressed appropriately or otherwise not fit to drive legally/safely. After the 3rd missed appointment, the student will be dropped from the program and all payments made to CC Drivers JA will be forfeited.

D. **PLEASE TAKE SCHEDULING YOUR LESSONS SERIOUSLY!** A deposit of \$2,000.00 is required to schedule your lessons. While we understand that emergencies may occur, forgetting about a lesson does not qualify as an emergency. 24 hour lesson cancellation is required to allow us to fill the lesson slot with waiting clients. If you arrive late please note that your time starts as scheduled and as such you will be only given the remainder of your time scheduled.

(Cancellation fees will be paid directly to CC Drivers JA prior to the next lesson). Initials \_\_\_\_\_

E. Rules/Requirements. The Rules/Requirements is applicable to the student at all times during driving lessons. Client/Student acknowledges that failure to abide by the Rules/Requirements is a violation of this agreement and may result in the dismissal from driving lessons. F. Termination/Refunds. Except as stated in Section C, the driving lesson agreement may be terminated by either party. In the event of termination, CC Drivers JA will refund the unused portion of driving lessons (*less a 20% processing fee*). Refund will be issued in 15 days after written request. Initials \_\_\_\_

G. Insurance. CC Drivers JA agrees to carry and maintain in effect, at all times throughout the performance of the driving instruction agreement, general liability and business auto insurance coverage.

H. Limitation of Liability. CC Drivers JA shall not be liable for any injuries the student receives during driving instruction that police have determined to be the student's fault. Participant's exclusive remedies for any and all claims related to the services provided by CC Drivers JA under the driving instruction agreement shall be limited to the total payments made to CC Drivers JA.

I. Notices. All notices or other communications required or permitted to be given shall be in writing (letter, email or fax) and delivered by such means or in person to the other party.

J. Amendments. No change or modification of the driving agreement shall be valid unless agreed upon by CC Drivers JA and Client, in writing and signed by both parties.

K. Severability. If any section or clause of the driving agreement shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section or clause shall not affect the remaining provisions of the driving agreement.

L. Agreement. This agreement constitutes the entire contract between the school and the client, and any verbal assurances or promises not contained herein are not binding on either the school or client. Initials \_\_\_\_
