Accomplishment/Goals for the Year - Committee Chairs

Annual Executive Summary: Bonnie Lyon

Homeowner comments this past year with remarks following.

R&R for waste receptacle storage: Most are in compliance with few exceptions after over one year of enforcement.

Sidewalk access: While enforcement remains the responsibility of King County Sheriff's Office, we encourage each one to consider their responsibility to our neighbors who have ADA requirements. When residents of the community or their visitors impede access by parking on sidewalks, they are forcing pedestrians to enter the street. We ask our residents to be considerate of others. A benefit to parking correctly in the street is that vehicles narrow roadways and immediately cause drivers to slow, studies prove.

Future goals include: Improving planting rounds, upgrading common properties including basketball court at Allen Park, submitting for upcoming grant opportunities to include Last Splash event and basketball court improvements.

Common Property Committee: David Dennis

Working with Green Effects to improve the upkeep of the common properties. They will schedule a cleanup of Toddler Park to include clearing saplings and low brush to 'daylight' the higher area and discourage vandalism and loitering. They will also schedule a finish to the ivy clearing on the sidewalk at Madsen Creek. Additionally, we reviewed what needs to happen in Allen Park to provide a safe playing field and to address soggy areas. They will be scheduling roundabout work to begin in October.

Cleaned overgrowth onto sidewalks in Allen Park. Replaced one of the rotted timbers bordering the play area. Replaced eyebolts at driveway for security of park. Repaired the horseshoe pit inadvertently damaged by lawn care company. Ordered play chips for both play areas.

Met with a homeowner who wants to form a pool of homeowners as "Friends of Allen Park." They will be focused on creation of a soccer pitch and rehabilitation of the basketball court.

Thank you to several volunteers who removed our US flags along with Jim Canterbury. Thank you to Jim Roberts who installed wayfinding signage at Div. 23 (formerly Kensington).

Property Maintenance Committee: Andrew Jones

A total of 1,056 inspection violations were written up which resulted in 933 inspections notices being sent to property owners. There was a total of 253 notices sent to property owners for violations related to expired vehicle tabs, trailers, tarps, boats etc. See attached table for a more detail review. Please understand that not all inspection write ups received authorization for notices to be sent. As of this writing some notices have not been sent due to processing time required to turn inspections into notices sent.

Security Committee: Jack Bramson

The following is the FGHOA security committee report for the fiscal period through September 2018:

The Securitas report stats revealed the following notable trends:

- Reported burglaries were down by 50%, from 4 to 2
- Abandoned vehicles were significantly up from 29 to 153
- Alarm calls home/vehicle were up from 30 to 51
- Open garage doors were significantly up from 399 to 653

The FGHOA Board of Trustees voted to renew the Securitas security contract for another year.

The contracted King County Sheriff's patrols, which this past year included some patrols between the hours of 10:00 pm and 6:00 am, resulted in several arrests. In addition to high visibility patrols, an emphasis was in the school areas/during school start/end hours, the KCSO provided intensive enforcement of traffic laws.

There is no particular reason as to the increase in abandoned vehicle activity. The KCSO strongly urges all FGHOA citizens/residents to report crimes/criminal activity to the Sheriff's Department as that is what determines their deputy resource deployment. Fairwood Greens is still considered to be one of the safest communities in unincorporated King County.

External Affairs/Community Relations Committee: Cathryn Hummel Over the past year, information was provided about 31 local events taking place in and around our area to provide homeowners the opportunity to be active in the community.

Early in the summer several FGHOA Board Members attended the Community Area Town Hall to ask questions of and speak about issues to the local elected officials and County representatives.

Puget Sound Energy replaced a gas main under and around Fairwood Boulevard and temporarily patched the roadway this summer. The PSE Project Manager has reported the roadway will be repaved; permits are being obtained and scheduling is being worked on with the asphalt company.

This summer External Affairs also reported about Lakeside Industries' proposed asphalt plant on Highway 169. Homeowners are encouraged to learn about the plant and voice their opinions.

Town Meeting: Bonnie Lyon

Homeowners were supportive and thanked the Board for their service. A homeowner stated she loved the neighborhood and liked that there is an active Board. The Board is doing a thankless job, but they are doing a good job. Thanks for your involvement.

Homeowners commented about property maintenance issues. A homeowner stated she feels threatened, bullied, and targeted. A homeowner was concerned the fines were revenue driven. A homeowner received a letter about weeds on his property; however, many other homes have similar issues. A homeowner doesn't remember receiving the letter about the transition regarding property maintenance. More time should be given for compliance. A homeowner was concerned about the elderly who get letters. A homeowner hoped that homeowners were not being written up because of dead lawns due to the dry summer. A homeowner suggested the Board give feedback about ATC. Enforcement is inconsistent and doesn't feel neighborly.

A homeowner stated tree branches are overhanging sidewalks.

Homeowners stated their views for and against Allen Park activities.

A homeowner wanted assurance that the green belts and frontages are being maintained.

A homeowner would like to see resurfacing of Fairwood Blvd.

A homeowner asked if there is an effort to make Fairwood a city.

Homeowners asked why adult family homes are being allowed when there is a no business rule.

A homeowner was concerned about cars that never move.

A homeowner was concerned about trees being cut down by new owners. It affects the beauty of the community.

Election Results: Bonnie Lyon

The election was conducted, closed, and the votes tabulated. Jim Canterbury, Cathryn Hummel, and Bonnie Lyon were reelected to the Board.

MOTION: To adjourn the meeting and move into Executive Session to elect new Officers and discuss personnel matters. **Second:** Yes. **Discussion:** None. **Vote:** 8-Yes, 0-No. **MOTION CARRIED.**
