#### **Security Committee:** Jack Bramson

Following is the Security Committee report for the reporting period of December 2015 through January 2016:

The King County Sheriff's office performed 23 Fairwood Greens dedicated patrols. These patrols resulted in the issuance of 3 NOI's (tickets) for traffic violations, 19 warnings for traffic related violations and 10 other types of actions including a stolen vehicles recovery, Identity Theft report and assisting a lost and disoriented elderly person. It should also be noted that in addition to traffic enforcement, we had asked the KCSO to be extra vigilant during December and to patrol neighborhoods to prevent package theft during the Christmas season. This did result in KCSO stopping one suspicious vehicle cruising a neighborhood but did not result in any action. The number of reported package thefts did appear to be less than some previous holiday seasons.

It should also be noted that FGHOA will incur a slightly higher KCSO patrol hourly rate. This will apply only when Sgt. Thomas Collins is patrolling. His services will be billed at the Sgt's. hourly rate of \$61.35 as compared to the Deputy hourly rate of \$50.78. This was agreed to as Sgt. Thomas Collins has agreed to take over responsibility for managing the FGHOA KCSO off duty patrol duties. Deputy Sam Shirley who had previously held this role has been reassigned and does not have the time to dedicate to this responsibility.

Additionally, there has been an increase in property vandalism reports and KCSO is aware of this.

Winter Travel Tips might be a good reminder to our neighbors:

- Check that your car is in good condition before bad weather hits. This includes the battery, anti-freeze, tires, and wiper fluid/blades.
- Keep seasonal emergency equipment in the car. Along with your regular roadside emergency kit, include sand/rock salt/kitty litter, an ice scraper, and small shovel.
- · Avoid driving during heavy snowfall or ice storms.
- Don't abandon your vehicle in the road. If you must leave your car, pull off the road as far as safely possible so emergency vehicles can still get through.
- · Make sure your fuel tank is at least half-full.
- · Don't leave your car running unattended, even for brief periods of time.
