The King County Sheriff's Office performed 12 dedicated FGHOA patrols during this reporting period. In addition to providing a high visibility presence, these patrols resulted in the following activities:

- 1 Traffic NOI (ticket) issued
- 4 Traffic related warnings issued
- 8 Citizen contacts were initiated
- 1 Citizen assist of a lost elderly male
- 2 Patrol assists
- 2 Nighttime patrols (between 2200 0600) were performed

The Securitas monthly report showed an increase in abandoned vehicles and a slight uptick in mail/package theft.

Vehicle vandalisms declined over prior periods.

There was also a marked increase in open garage doors observed.

We again urge all Fairwood residents to report any crimes or suspicious activity to the KCSO so that they can respond and record the activity which is used for resource deployment purposes.
